

## Use of Hartford Steam Boiler Ireland Limited (HSB IE) Registration Marks and Identification Number

### 1. Use of HSB IE Logo and Registration Marks



The Manufacturer shall have physical control of the Certificate of Registration and have designated responsibility for the control of the application and its reproduction. The Certificate of Registration and HSB IE Logo shall only be used or referenced in professional, technical, trade or other business publications and announcements that accurately represent the Manufacturer's scope of registration in such a way that does not imply product endorsement based upon registration by HSB IE. The HSB IE Logo shall not be displayed on any product, personnel certification, product certifications, product labels, containers or packaging.

### 2. Use of HSB IE Mark and Notified Body Identification Number – 2833

The Manufacturer's Quality Management System shall include provisions for the control and use of HSB IE's Notified Body's and/or Inspection Body's identification number

- a) Authorisation to use HSB IE's Notified Body identification number 2833 or stamp is granted exclusively to the Manufacturer
- b) The Manufacturer is exclusively granted permission to affix HSB IE's Inspection Body identity mark or stamp, as outlined in Directive 2008/68/EC according to the annexes concerning the inland transport of dangerous goods, applicable to the certified scope
- c) The Manufacturer shall comply with the provisions of the certification scheme, general rules governing the form, placement and use of CE or TPED marking contained in or referenced by the PED, CPR, TPED or CDG
- d) Manufacturer's for whom HSB IE has suspended or withdrew certification cannot use the identification number, Inspection Body identity mark or stamp during the period of suspension or withdrawal of certification.
- e) If certification terminates or expires, the Manufacturer shall immediately cease using HSB IE's identification number and/or HSB IE's Inspection Body identity mark or stamp
- f) The Manufacturer shall cease using the number 2833 with the CE marking and HSB IE's Inspection Body identity mark or stamp in a way that HSB IE deems inadmissible.
- g) The Manufacturer cannot assign its right to use HSB IE's identification number or HSB IE's Inspection Body identity mark or stamp to any other entities
- h) HSB IE's Notified Body identification number 2833 or HSB IE's Inspection Body identity mark or stamp with or without ADR or CE marking cannot be used on business cards and/or stamps of the Manufacturer's personnel

- i) For Quality System Certifications, the Manufacturer's Quality Management System shall include provisions for the control and use of HSB IE's Notified Body Number.
- j) In the event of abuse in using HSB IE's identification number and/or HSB IE's Inspection Body identity mark or stamp by forgery, misleading references or other means the Manufacturer's certification shall be suspended or withdrawn
- k) In the event of such abuse, HSB IE reserves the right to undertake relevant actions, including but not restricted to:
  - i. demand performance of relevant corrective actions, which may include removal of the identification number on all affected equipment;
  - ii. suspension or withdrawal of the certificate;
  - iii. publish information concerning any illegal or false reference to the identification number of HSB IE; and
  - iv. resolve the matter in court.

### 3. Reproduction of Certificates

- a) Certifications issued by HSB IE, shall only be reproduced in their entirety
- b) Should the Certificate be suspended, withdrawn, or terminated, the manufacturer shall discontinue its use or reference in all advertising matter
