

## Use of HSB UK Ltd Registration Marks and Identification number.

## 1. Use of HSB UK Ltd. Registration Marks



The Manufacturer shall have physical control of the Certificate of Registration and have designated responsibility for the control of the application and its reproduction. The Certificate of Registration and HSB UK Logo shall only be used or referenced in professional, technical, trade or other business publications and announcements that accurately represent the Manufacturer's scope of registration in such a way that it does not imply product endorsement based upon registration by HSB UK. The HSB UK Logo shall not displayed on any product, product certifications, product labels, containers, or packaging

## 2. <u>Use of HSB UK Ltd. UK Approved Body identification number – 2561</u>

The Manufacturer's Quality Management System shall include provisions for the control and use of HSB UK's UK Approved Body's identification number

- Authorisation to use HSB UK's Approved Body's identification number 2561 with the UKCA or CE+UKNI marking is granted exclusively to the Manufacturer with respect to the scope for which certification has been granted
- 2. The Manufacturer shall comply with the provisions of the certification scheme, general rules governing the form, placement and use of UKCA or CE+UKNI marking contained in or referenced by the PESR, UK CPR, UK TPE, CDG or NPIP
- 3. Manufacturer's for whom HSB UK has suspended or withdrew certification cannot use the identification number during the period of suspension or withdrawal of certification
- 4. If certification expires, the Manufacturer shall immediately cease using HSB UK's identification number
- 5. The Manufacturer shall cease using the number 2561 with the UKCA or CE+UKNI marking in a way that HSB UK deems inadmissible.
- The Manufacturer cannot assign its right to use HSB UK's identification number to any other entities
- 7. to make claims regarding certification only with respect to the scope for which certification has been granted;
- 8. HSB UK's logo may not be applied by certified clients to their inspection reports or certificates
- 9. HSB UK's Approved Body identification number 2561 with or without UKCA or CE+UKNI marking cannot be used on business cards and/or stamps of the Manufacturer's personnel
- 10. UKAS accreditation shall not be used in such a way as to imply that UKAS accepts responsibility for the accuracy of a result, or any opinions, approvals or interpretations derived. The conditions for use of the UKAS accreditation logo and symbols has been applied to HSB UK's accredited certificates under conditions outlined in the Department for Business, Energy & Industrial Strategy (BEIS) publication 'The National Accreditation Logo & Symbols: Conditions for use by UKAS and UKAS accredited organisations' and UKAS Gen 6 'Reference to accreditation and multilateral recognition signatory status by UKAS accredited bodies'.



- 11. In the event of misuse or abuse in using HSB UK's identification number by forgery, misleading manner or misleading references or by other means the Manufacturer's certification shall be suspended or withdrawn
- 12. In the event of such abuse, HSB UK reserves the right to undertake relevant actions, including but not restricted to:
  - demand performance of relevant corrective actions, which may include removal of the identification number on all affected equipment
  - b. suspension or withdrawal of the certificate
  - publish information concerning any illegal or false reference to the identification number of HSB UK
  - d. resolve the matter in court

## 3. Reproduction of Certificates

- a) Certifications issued by HSB UK, shall only be reproduced in their entirety
- b) Should the Certificate be suspended, withdrawn, or terminated, the manufacturer shall discontinue its use or reference in all advertising matter including website and digital print
- c) Amending all advertising matter when the scope of certification has been reduced
