- Detailed narrative of the potential client including a description of their: operation, operating territory and territory expansion information
- Completed ACORD applications for each line of business as well as the ACORD Commercial Insurance Application
- Business/growth plan for the company
- Provide bordereaux for last year as well as the information below if not included on the bordereaux (if available):
  - Renter detail including: age and unique ID or name, state of rental, rental length of time, actual pick-up time, actual drop-off time, year, make/model of vehicle, odometer mileage on the vehicle
  - Provide a description of the vetting process for renters: i.e. MVRs ordered, background checks performed, credit score ordered
  - Are there mandatory coverages for the renter? If yes, provide coverage details including limits and deductibles.
  - Can the renter purchase optional insurance? If yes, what are the liability limits? If limits can vary, provide breakdown of how liability limits apply.
  - Can comprehensive/collision coverage be purchased? If yes, provide deductible options.

- Are any telematics devices installed on the vehicle or within the application that measure and/or capture driver behaviors and vehicle operation? If yes, please provide details.
- Vetting process used to qualify the owners vehicle including maximum age
- Identify and describe the operating platform and indicate whether self-developed or purchased from outside sources

- Currently valued loss runs from the incumbent carrier including a description of the loss as well as breakouts between reserved and paid - both loss and claims expense
- Gross merchandise value for the past 12 months by each operating territory
- Projections in the territories where operations are planned
- Any manuscript policy forms
