Jurisdictional Inspection Requirement Form for Boilers and Pressure Vessels

The Technical Standards and Safety Authority (T.S.S.A.) will be introducing new regulations for boilers and pressure vessels, July 1, 2018.

- Ontario law requires routine jurisdictional inspections of boilers and pressure vessels to ensure they're in safe working order.
- If your policy includes equipment breakdown coverage for boilers and pressure vessels, we will continue to complete the required inspections and file a **Record of Inspection** with T.S.S.A. on your behalf for no additional charge.
- Effective July 1, 2018, you will be required to obtain the Certificate of Inspection from T.S.S.A for a fee. For more information, visit TSSA's website.
