Requirements for all companies

- Detailed narrative of the potential client including a description of their operations, operating territory, and territory expansion information
- Completed ACORD applications for each line of business as well as the ACORD Commercial Insurance Application
- Driver onboarding criteria for the Transportation Network Company including minimum driving age and background check procedures. (This will require documentation above and beyond a link to the website.)
- Detailed description of any telematics devices that are installed on the vehicle or within the application that measure and/or capture driver behaviors and vehicle operation
- Current and prospective business plan
- Maximum allowable vehicle age
- Identify and describe the operating platform and indicate whether it is self-developed or purchased from an outside source

Requirements for start-ups

- Biographies of the founders/owners
- Estimated revenue by operating territory
- Funding details
- Breakdown of mileage projections for each period by operating territory

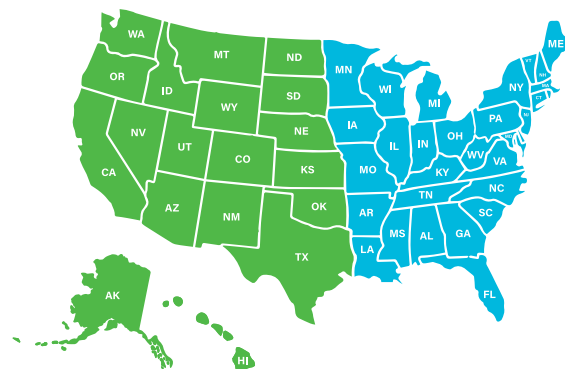
Requirements for established companies

- Current valued loss runs including a description of the loss as well as incurred and paid claims details for both indemnity and expenses
- Breakdown of mileage by month of Period 1, 2, and 3 in each city/state where they were operating in for the previous 12 months
- Net ride revenue for the past 12 months by each operating territory
- Breakdown of mileage projections for each period by operating territory
- Copies of any manuscript policy forms
